 Create networking opportunities through strategic events for business owners and community investors to ensure that all Haywood County residents are educated regarding the efforts of all community partners and provided equitable assets needed for success in these rapidly changing times. We will begin hosting Chamber Business After Hours and Chamber luncheons to allow networking and to showcase local businesses. Your Chamber will also work with and support IDB with existing industry to help facilitate an environment that will hopefully foster a lasting connection between our existing industries and the community in which they serve. We will meet with and listen to the needs and concerns of existing industry, letting each know that they are and will continue to be a huge value and asset to Haywood County, and will endeavor to help find ways in which the community can further support their success.

- Collaborate with current and new economic development partners and work with Retail Strategies, a company that comes highly recommended from a grant opportunity from TNECD, to ensure the success of economic development while referencing community tools such as the Future Land Use Plan introduced by LRK. Also, critical to the success of this plan is to work with those retail establishments already in our community and help them grow.
- Market the community to the outside world. The world will beat a
 path to West Tn as Blue Oval City opens its doors. It is imperative
 that those who are thinking of relocating to the area consider
 locating here. The Chamber plans to continue the course by
 working with Mad Genius and the JECDB to create a cohesive
 community marketing strategy. This special project will require
 additional funding at a later date.
- Collaborate with all partners in the community which have critical roles in ensuring the success of our future. These include City and County government, IDB, The Mega Site Authority, West TN Delta Heritage Center, Main Street, The Arts Council, HRC, Vision Haywood County and The Greater Jefferson Street Revitalization Initiative.
- Respond to the concerns and needs of the Chamber's current and future investors. Their continued support is crucial to the success of the chamber.

Hopefully, you can see that to succeed in its' mission, the Chamber requires strong leadership which is why the 2025-2026 budget includes a compensation package for retaining the Executive Director with the requisite experience, skills, and talents to effectively manage all the various plans of the Chamber. It also includes crucial funding for administrative support staff and funding for the execution of all actions identified above.

We are requesting that Haywood County continues to support the Brownsville Haywood County Chamber of Commerce with your upcoming budget and invest \$75,000 for the Budget year of 2025 – 2026 to assist in these efforts.

Dear Mayor Livingston:

Once again, our cooperative fire control agreement between the Tennessee Division of Forestry and your county government to maintain the West Tennessee District's Forest fire control operations needs your county's continued support.

As we do each year our department is requesting that you place our annual appropriation of \$2000.00 back into the County budget for the 2025-2026 fiscal year. This appropriation is requested to maintain the continuance of the Cooperative Fire Prevention and Control Program in your county.

As always, our fire crews and fire control equipment are available for assisting your county resources in fire suppression activities. Another of the many benefits Tennessee Counties receive from the Tennessee Division of Forestry is the fire permit system which is in operation during fire season (October 15th through May 15th). Managing when burn permits are issued provides a measure of control of the timing of outdoor burning by restricting burning permits when weather conditions make it likely that fires will escape. Also an online permit system to provide convenience and better access to the public for obtaining a burn permit. The Address of this web site is:

The Division of Forestry has consistently fulfilled all of the terms of our cooperative fire control agreement for forest fire protection services for **Haywood** County since it was signed by both parties in the 1950's. Dear Mayor Livingston:

Since its founding in 1975, WRAP (Wo/Men's Resource & Rape Assistance Program) has been a cornerstone of support for victims of domestic violence and sexual assault across 19 counties in rural West Tennessee. Dedicated to empowering survivors—primarily women, many of whom have children—WRAP's mission is to help them escape abusive environments, rebuild their lives, and create safer, healthier futures for themselves and their families. To achieve these goals, WRAP offers a comprehensive range of services, including a 24/7 crisis line, two emergency safe homes (WRAP House Jackson and WRAP House Union City), court and hospital advocacy, counseling and therapeutic services, case management, resource linkage, and transportation—all designed to foster justice, safety, independence, and well-being for victims and their children.


In Haywood County, WRAP operates out of its office at the Family Justice Center, One Safe Place at 110 N Russell Avenue in Brownsville, staffed by Maura Joyner, Domestic Violence Response Specialist, and Candice Sanders, Sexual Assault Response Specialist. The pressing need for WRAP's services in the community is reflected in local crime data: during 2023-2024, law enforcement agencies reported 139 incidents of domestic violence and sexual assault—accounting for 32% of all crimes against persons in the county. WRAP responded by providing advocacy and support to 86 survivors who sought assistance, offering them critical resources and pathways to recovery.

WRAP is anticipating a significant reduction of approximately 40% in federal funding for the upcoming fiscal year. This financial shortfall will regrettably necessitate a similar reduction in staffing levels, even as the demand for WRAP's services is expected to remain high. To ensure that victims of domestic abuse and sexual assault in Haywood County continue to receive essential, life-saving support, WRAP respectfully requests \$5,000 in funding to help offset this gap. This contribution will directly support critical services such as our 24/7 crisis line and court advocacy, which empower survivors to find safety, independence, and hope during their most vulnerable moments.

We deeply appreciate the longstanding collaboration and support from Haywood County, which has been instrumental in our efforts to serve the community. Your commitment to working alongside WRAP has been invaluable, and we look forward to continuing this partnership. On behalf of the children in Haywood County, who are served by the Exchange Club Carl Perkins Center for the Prevention of Child Abuse, I would like to extend a very special thank you for the support given us over the years.

The mission of the Center is to provide support to families in preventing and dealing with child abuse in West Tennessee and to help both parents and children meet the practical needs of preserving and improving the quality of family life.

City Officials and Finance Committees are beginning to meet throughout West Tennessee to formulate their upcoming budgets for 2025-2026. The Volunteer Board and staff of the Center are working very hard to secure more funds to support the services it provides; however, many grants have been reduced or require matching funds. Therefore, we are asking for help in our local communities to assist with funding for the services being provided. It is with this in mind; the Center requests \$7,500 for the 2025-2026 operating budget from Haywood County, Tennessee.

At this point in our fiscal year of 2023-2024, we have been able to provide services to **99 individuals in Haywood County**. We staff a 24-Hour Information Hotline Number; we offer the classes/programs in: Crisis Intervention, Parent Training and Parenting Groups, Child Victims Program, Child Sexual Abuse Victims Group, and Child Advocacy Services. The Center also provides emergency financial assistance for those in our programs; which range from purchasing a mattress for a child to sleep on, to paying a portion of a utility bill to keep the house warm/cool. We are continuously working in your community on child abuse education and prevention. All of these services are offered FREE to the public.

As we progress in the current fiscal year, we are experiencing an increase in these numbers and anticipate them to continue to increase as we strive to reach out to those in need. Without the support of the community, we would not be able to continue to provide quality services to those who need it most. The Center is an approved and licensed child abuse prevention agency with the State of Tennessee and is a tax-exempt 501(c)(3) agency. The Center is in good standing with the State with regular audits. We are happy to meet with you to discuss our request and answer any questions you might have about the Center, its services, and this request.

Visit Brownsville respectfully requests your continued support of our efforts to attract tourists, and the resulting economic impact, with your annual contribution of \$15,000. Your contribution goes directly to marketing our community as a preferred destination in West Tennessee.

This past fiscal year, Haywood County partnered with Stanton in funding the Stanton Welcome Center/Lending Library. The facility, centrally located for ease of access to all Haywood County residents west of the Hatchie River, is growing with the hiring of an additional librarian and extended hours to be available for our youth and adults. Our staff is putting in place adult and child programs to lead our community into the future and prepare for an increase in our residential population. We are poising to work in collaboration with the Ford Community Center to ensure that our Haywood County residents are set up for success.

Some of the services provided by the Welcome Center/Library included:

- 1. Access to books, magazines, and a wide range of reading, research, and archival material for Haywood County residents and surrounding counties
- 2. Free wireless internet connectivity throughout a large portion of town
- 3. Access to net-connected computers during all operating hours
- 4. Staff members available at all times to assist Library patrons
- 5. Assistance in completing job applications, social security documentation, employment documents, and guiding patrons in accessing social services
- 6. Free cloud-based math tutoring for all residents of Haywood County
- 7. Recruiting for GED classes
- 8. Access to online classes
- 9. Children's events at the library (including Headstart students)
- 10. Senior Citizen's events at the library
- 11. Meeting space for community groups
- 12. Access to Stanton genealogical and cemetery archives, and online resources
- 13. Outreach via social media
- 14. Marketing efforts for Stanton and Haywood County
- 15. Connecting Haywood County residents with social services available in West Tennessee.

As the coming fiscal year approaches, we trust Haywood County will continue to partner with Stanton in funding the Stanton Welcome Center/Lending Library. In FY 2025, Haywood County has generously partnered with us to provide \$20,000 to the program. This contribution helped to offset our nearly \$60,000 budget. Stanton has provided additional support for the Library both in financial, but also in technical assistance (e.g., computer repairs/replacement and

maintenance, database management), labor (ongoing repairs and maintenance of the building), marketing, and additional staffing when needed.

With the addition of an additional employee and the increase in hours and offerings, our appropriation will need to increase. Our request this year is for \$35,000, with Stanton providing additional assistance in terms of financial, technical, labor, marketing, and staffing resources. This is a partnership to ensure that all Haywood County residents prosper.

The West Tennessee River Basin Authority is charged with the preservation of the flow and function of the Forked Deer, Hatchie and Obion River Basins. It is a part of our mission to restore, where practicable, natural stream and floodplain dynamics; maintain or stabilize the function of altered streams and rivers; and provide regional and local leadership for the conservation and sustainable utilization of these river basins. Our area of responsibility continues to cover 20 counties in West Tennessee.

Over the past several years the Basin Authority responded to river maintenance challenges resulting from floods and storms through the use of an amphibious trackhoe and traditional heavy equipment on the Obion, Hatchie and Forked Deer River systems. A number of large channel blocking drifts have been removed from the Hatchie and the South Fork Forked Deer Rivers. If drifts are not removed on a routine basis, the channel can become totally blocked, upstream flooding will increase, and economic loss will occur. We have one work crew devoted almost entirely to this type of work on the Hatchie, and we frequently remove logiams from the South Fork Forked Deer River.

We respectfully request funding through your county budget in the amount of \$18,900. We welcome the opportunity to meet with you and your County Commission or Budget Committee to discuss the objectives of the West Tennessee River Basin Authority and how your participation is critical to our future success. We thank you for your continued support and look forward to serving Haywood County.

West Tennessee River Basin Authority Summary of Recent and Ongoing Projects in Haywood County

The WTRBA has the current projects in the planning phase or implementation phase in Haywood County:

- Perform routine mowing and maintenance on 3 of the 4 Flood Control Structures in Haywood County.
- Provide routine amphibious and./or land-based stream and river maintenance throughout the county.
- Conduct non-routine amphibious and/or land-based stream maintenance along Little Muddy, Muddy Creek, Hatchie Bottom and other areas when identified and deemed necessary.
- Continue to assist Haywood County landowners, City and County officials, and others with technical advice and/or assistance on an as needed basis.
- Work with TDOT to provide stream mitigation resources on Little Muddy Creek to support development of new highway infrastructure for growth and continued development of Blue Oval City.
- Participate in a Blue-Ways working group to identify and implement increased recreational access along the Hatchie River.

In 2024 the WTRBA:

- Conducted routine maintenance on 2 of the 4 Flood Control Structures in Haywood County.
- Provided amphibious and/or land-based maintenance along Big Muddy Creek, Little and Muddy Creek
- Performed ~2.5 miles of non-routine amphibious maintenance along Little Muddy in Haywood County.
- Performed ~11.5 miles of non-routine amphibious maintenance along Muddy Creek in Haywood County.
- Provided Haywood County landowners, City and County officials, and other with technical advice and/or assistance as deemed necessary.
- Continued assisting with stream, wetland, and flood related issues at Blue Oval City in partnership with the Megasite Authority and future tenants.
- Developed stream mitigation plans along Big Muddy Creek in coordination with TDOT and Blue Oval City.

In 2023 the WTRBA:

- Conducted routine maintenance on 2 of the 4 Flood Control Structures in Haywood County.
- Provided amphibious and/or land-based maintenance along Big Muddy Creek, Little and Muddy Creek
- Performed non-routine amphibious and/or land-based maintenance in Haywood County on an as needed basis.
- Provided Haywood County landowners, City and County officials, and other with technical advice and/or assistance as deemed necessary.

- Continued assisting with stream, wetland, and flood related issues at Blue Oval City in partnership with the Megasite Authority and future tenants.
- Developed stream mitigation plans along Big Muddy Creek in coordination with TDOT and Blue Oval City.

In 2022 the WTRBA:

- Assisted with stream, wetland, and flood related issues at Blue Oval City in partnership with the Megasite Authority and future tenants.
- Performed routine maintenance on 4 Flood Control Structures located in Haywood County.
- Provided stream maintenance along Big Muddy Creek, Little Muddy Creek, and tributaries to the Hatchie River along Hwy 76 to Big Eddy.
- Performed non-routine amphibious or land-based maintenance on an as needed basis.
- Continued to provide technical advice and/or assistance to Haywood County landowners, City or County officials, and others, as necessary.
- Development of future stream mitigation resources to support continued economic growth in Haywood County.

In 2021 the WTRBA:

- Performed maintenance on 4 Flood Control Structures located in Haywood County.
- Continued Beaver Damage Management on an unnamed tributary to Cypress Creek.
- Provide Beaver Damage Management on a highly dysfunctional section of Big Muddy Creek. Performed follow-up stream maintenance with amphibious trackhoe as necessary.
- Performed amphibious or land-based stream maintenance as needs are identified.
- Provided technical advice and/or assistance to Haywood County landowners, City or County officials, or others, as necessary.
- Continued to assist with the 'Mega-Site' development in Haywood County through stream mitigation project.

In 2020 the WTRBA:

- Performed mowing and routine maintenance on 3 Flood Control Structures.
- Performed site assessments and provided technical advice for two private landowners.
- Assisted with stabilization technical assistance for homeowner on Hatchie River downstream of I-40.

In 2019 the WTRBA:

- Performed mowing and routine maintenance on 3 Flood Control Structures.
- Performed over 3 miles of stream maintenance on Big Muddy Creek, Baxter Bottoms, Kail Creek and the Hatchie River using the amphibious trackhoe and land-based equipment.
- Performed site assessments on Nixon Creek and Hatchie River. Flew drone for assessment on Meridian Creek and advised landowner, no blockages only silting.
- Completed a Mitigation Banking Instrument for the 'Mega-Site' in Haywood County.

In 2018 the WTRBA:

• Performed mowing and routine maintenance on 2 Flood Control Structures.

- Performed Beaver Damage Management and removed blockages with an amphibious trackhoe that was flooding a home on Estanaula Road.
- Performed stream maintenance on Muddy Creek, Big Branch, and Nixon Creek using the amphibious trackhoe and land-based equipment.
- Performed stream maintenance on the Hatchie River using the amphibious trackhoe.
- Continued to develop a stream/wetland mitigation bank at the MegaSite to provide the necessary credits for potential prospects.

In 2017 the WTRBA:

- Performed mowing on 3 Flood Control Structures located in Haywood County.
- Performed stream maintenance on the Hatchie River at several locations using the boat and land-based equipment.
- Removed a channel blocking log jam on Big Muddy near Stanton.
- Under an annual agreement with USDA, performed Beaver Damage Management at locations in Haywood County


