COMMISSION RULES MANUAL



- The Haywood County Commission is the county's legislative body (CLB) and governing board for Haywood County Government.
- Commissioners are elected by the citizens of Haywood County and are responsible for adopting the county budget, setting the tax rate, exercising zoning authority in unincorporated areas, and enacting laws authorized by the State of Tennessee.
- The Commission consists of 20 commissioners, with two commissioners elected from each of the county's 10 voting districts. Commissioners serve four-year terms and meet regularly to conduct county business in a transparent and public setting.





Standing Committees

Commission standing committees are advisory and exist to assist the Commission in the performance of its duties. Their charge is to review matters within their areas of responsibility, provide analysis and recommendations, and report back to the full Commission for final action. Standing committees must be authorized by resolutions and are reappointed each October through the nominating process. Their purpose and function are described in the Commission Rules Manual. The Commission has established the following committees by tradition or resolution:

1. Budget
2. Capital Improvement Planning
3. Education
4. Local Government (Rules)
5. Public Safety
6. Solid Waste
